

2019 HOLIDAY SHOPPING SWEEPSTAKES OFFICIAL RULES

HOW TO PARTICIPATE: When you make an eligible purchase at an Antigo/Langlade County Chamber Member Business and/or a Langlade County Business during the period beginning October 20, 2019, and ending December 20, 2019, your sales receipt can get you an entry into our sweepstakes. An Antigo/Langlade County Chamber Member Business receipt provides TWO (2) ENTRIES, a receipt from any other Langlade County Business provides ONE (1) ENTRY. The receipt may only be used once to enter the sweepstakes.

HOW TO ENTER: You may enter the sweepstakes by bringing your receipt to the Antigo/Langlade County Chamber of Commerce office during regular business hours. All entries for the Thanksgiving Drawing must be received at the Chamber Office by 2:59 pm CST on November 20, 2019. All entries for the Christmas Drawing must be received at the Chamber Office by 2:59 pm CST on December 20, 2019.

No purchase or payment of any kind necessary to win. Anyone may enter the sweepstakes by mail by hand printing your name, age, complete address, E-Mail, daytime & evening phone numbers on a 3 x 5-in. a piece of paper and mail it, in an envelope, to Antigo/Langlade County Chamber of Commerce, 1005 S. Superior St., Antigo, WI, 54409. Mail-in entries must be postmarked by November 13, 2019, and received by November 20, 2019, for the Thanksgiving Drawing. Mail-in entries must be postmarked by December 13, 2019, and received by December 20, 2019, for the Christmas Drawing. Only one mail-in entry per person will be accepted. All entries become the property of Sponsor and will not be returned.

PRIZE DESCRIPTION: One (1) \$50 Gift Certificate will be awarded on or about November 20, 2019, at 3 pm CST. One (1) \$50 Gift Certificate will also be awarded on or about December 20, 2019, at 3 pm CST. Prize may not be substituted, transferred, or exchanged except at the sole discretion of the Sponsor. Grand Prize Winner will be required to claim the prize at the Antigo/Langlade County Chamber of Commerce office.

WINNER SELECTION: There will be two (2) drawings. The "Thanksgiving Drawing" will be on or about November 20, 2019, and the "Christmas Drawing" will be on or about December 20, 2019. One (1) potential winner will be selected in a random drawing from among all eligible entries received. The odds of winning depend upon the total number of eligible entries received. The winning entry will be posted at the Antigo/Langlade County Chamber of Commerce office and the Antigo/Langlade County Chamber of Commerce Facebook Page. The winning entry will be displayed for approximately fourteen (14) days after the drawing date, or until the winner claims his/her prize. If in the Sponsor's opinion, there is any suspected or actual evidence of tampering with any portion of the sweepstakes, the Sponsor reserves the right to terminate the sweepstakes and conduct a random drawing to award the prize using all eligible entries received as of the termination date.
